



**PRECAUTIONARY STATEMENTS**  
Hazards to Humans and Domestic Animals

- Corrosive: Causes skin damage. May be fatal if absorbed through skin.

**FIRST AID**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for further treatment advice.

**IF ON SKIN, CLOTHES:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**IF SWALLOWED:** Call poison control center or doctor immediately for treatment advice. Have person sip a glass of water, if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

**DIRECTIONS FOR USE**  
It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for protection regulation.

**WOOD TREATMENT:** SMDC-FUME is a liquid used to control internal decay in poles, pilings, and similar large timber members. Timber known to have internal decay should be scheduled for treatment before it has decayed to the point where replacement is necessary. A groundline area of a 40-inch circumference standing pole is taken as a guide and example for application of SMDC-FUME. For interior decay, bore four or five holes 3/4-inch in diameter and a length about 2 1/2 times the radius of the wood at about a 45-degree angle downward. The first hole should be at the groundline and succeeding holes about 6 to 12 inches higher and 90 degrees rotated from the next lower hole. Inject equal amounts of the fumigant into all holes using a total of 1 pint per pole on the average. Plug holes with treated wood plugs.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**PESTICIDE STORAGE:** Do not expose to extreme temperatures. Do not stack more than four drums high. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Protection Agency, or the Hazardous Waste representative at your EPA Regional Office for guidance.
